Dear Friends and Colleagues,

A very warm welcome to the Saint Mary's Centre 20th Annual Conference!

I write this with a degree of excitement and some trepidation, given that this will be the first time in four years that we have been able to hold the conference face-to-face and really experience all the benefits that a couple of days away from our regular roles, amongst like-minded colleagues, can provide, but conscious that this is the first conference we have planned without the expert guiding hand of our previous Clinical Director, Cath White. If my calculations prove correct, Cath will have been responsible for steering 17 out of 19 of the Saint Mary's conferences that have gone before us. So, no pressure for us then!

During the time that Cath was in post the digital landscape changed beyond recognition. Facebook was created on February 4th 2004, the first tweet was sent on March 21st 2006, WhatsApp was launched in 2009, closely followed by Instagram the following year, Snapchat was founded in 2011, and Tik Tok entered our lives in 2016. Since then, we have communicated with our fellow humans in ways previously unimaginable. We have watched our children experience life in a totally alien way to the childhoods we might have experienced in the latter part of the last century.

How often have we said to one another, "Life was so much simpler then?" Yet, all parents will appreciate the benefits that mobile technology offers us from being able to video call or message our offspring whenever, wherever, for that instant reassurance of their safety and whereabouts, to being able to track them on nights out, in ways that might under other circumstances mirror the behaviour of crazed stalkers (Life360 anyone?!) How often have we also said, "How did our parents cope when we used to set out on our bikes first thing in the morning, only to return hours later when hunger drove us home and no one had any idea where we were in that time in between?" But many of us will also recognise the instant mood lowering effects social media can inflict upon our youngsters when they see a post that makes them question their friendships, their self-esteem, their body image, their very identity. What a difficult line our youngsters, first-generation digital natives, have to tread these days, with us, the digital immigrants running behind with arms outstretched, as we did when we taught them to ride, and doing our best to guide them through a world we perhaps understand less than they do.

Whilst the aim of this conference is not to equip us with all the skills of a polished influencer, I do hope that we will learn together not just about the dangers of the digital world for our children and those we have the privilege of being able to work alongside in the many different roles we carry out, but also about the great strides we have made in being able to protect our next generation, and those that follow, from harm.

The programme looks set to provide us with two full days of stimulating and interesting presentations and promises lively debate and discussion.

Many thanks to our speakers for giving up their time to educate us, without you this event would not be possible.

Thanks also to our sponsors who help support us in our endeavours and a special thanks to Josh Edgar, our conference maestro, who has skilfully, and patiently, pulled this together – you are very much appreciated!
