

The Saint Mary's Sexual Assault Referral Centre is a pioneering collaborative venture which provides a comprehensive and co-ordinated forensic, medical, counselling and aftercare service to women, men and children living in Greater Manchester and Cheshire. The service is available to those who have experienced rape or sexual assault, whether this has happened recently or in the past. Established in 1986, the Centre is recognised nationally and internationally as a model of good practice in providing immediate one-stop services to adults of all ages. To date we have provided services to 24,510 clients. Since the Saint Mary's Children's SARC opened in 2006, the Centre has seen 6,398 children to date.

Welcome to Saint Mary's 16th Annual Conference

Rape: Not an isolated issue: Sexual violence and multiple types of abuse

The development of Sexual Assault Referral Centres in the UK over the last thirty two years has led to many advancements in the care of those reporting sexual violence.

Whilst the specialisation of services brings about its own benefits it should be appreciated that sexual violence does not take place in a vacuum. Many of the people seen in SARCs will have other problems, whether that be vulnerabilities such as mental health issues, learning disabilities or poor social circumstances. In addition it is not unusual for them to have been victims of multiple types of abuse such as domestic abuse, physical, emotional, financial.... What makes a person vulnerable to sexual violence will generally be applicable to other types of abuse.

We have long been arguing against the notion that a SARC service should be seen only as provision of the forensic medical examination, particularly an examination focussed solely on obtaining forensic swabs. Indeed "The swab is not the job" mantra should feature in any unofficial SARC mission statement.

If we agree that reducing a person's vulnerability to future abuse, of any type, and enhancing their overall wellbeing is a desired outcome, then we must broaden our approach to their assessment and enhance our response to meet their needs. Seeing sexual violence as a single issue will, in many cases, be naïve and futile. SARCs need to up their game, see their clients as whole people not just a "rape victim" and link in with other existing services if they really want to make a difference

I am grateful to the host of excellent speakers who will share their thoughts and experience on these issues. May I extend a warm welcome to all the delegates and thank you for taking the time out of busy schedules to listen, reflect and share your own thoughts and views. Thanks are also due to our sponsors who help support this event and of course a huge thanks to all those involved in the organisation of this conference. Lastly a special thanks to all the Saint Mary's SARC staff, at the Saint Mary's Centre and SAFEPLace Merseyside who are working hard to keep the service running whilst we are here.
